1. The Government of the United Republic of Tanzania has set aside funds for the operation of the *Kinondoni Municipal Council* during the financial year 2018/2019. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the *proposed construction of Magomeni market in Kinondoni Municipal Council*.
2. The *Kinondoni Municipal Council* now invites sealed Tenders from eligible *national* contractors registered or capable of being registered in *Class one with CRB in Building Works* for carrying out the *following major activities*;
 - i. Market Building
 - ii. Plumbing installations
 - iii. Electrical Installations
 - iv. Telecommunications and security installations
 - v. Lift Installations
 - vi. Air condition Installations
3. Tendering will be conducted through the *National Competitive Bidding* specified in the Public Procurement Regulations, Government Notice No.446 of 2013 and is open to all Tenderers as defined in the Regulations unless otherwise stated in the Tender Data Sheet.
4. Interested eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of the *Secretary of the Tender Board*,

Kinondoni Municipal Council Head Office located at Morogoro road, P.O. Box 30912, Dar es salaam from 7:30 am to 3:30 pm on Mondays to Fridays inclusive except on public holidays.

5. A complete set of Tendering Document(s) in *English* and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of *TZS 300,000.00*. Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to *Municipal Director*.
6. All Tenders must be accompanied by a Tender security in an acceptable form in the amount of *TZS 450,000,000.00* or freely convertible currencies in case of foreign Tenderers.
7. All Tenders in one original plus *three (3) number of copies* properly filled in, and enclosed in plain envelopes must be delivered to the address *Secretary of the Tender Board, Kinondoni Municipal Council Head Office located at Morogoro road, P.O. Box 30912, Dar es salaam* at or before *08th October, 2018 at 11:00 am local hours*. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the *Municipal conference hall, Kinondoni Municipal Council Head Office located at Morogoro road, P.O. Box 31902, Dar es salaam*.
8. Late Tenders portion of Tenders, electronic Tenders, Tenders not received, Tenders not opened at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
